1.0 RECOMMENDATION

1.1 BLS members urge Councillors to accept and support the actions of the NSW Minister for Planning, Hon. Rob Stokes, to resolve the Golf Course DA11/1728 with regard to the potential call-in of the golf course application at Long Bow Point and the overwhelming evidence of the likely adverse impacts of the proposed golf course on lake ecology.

2.0 SUPPORTING COMMENT

- 2.1 BLS understand that the NSW Minister for Planning, the Hon Rob Stokes, sought and has been advised by the Planning Assessment Commission that the golf course DA 11/1728 at Long Bow Point Lake Wollumboola Culburra Beach is State Significant, leaving the way open for the Minister to call in the application and to decide it.
- 2.2 Birdlife Shoalhaven has previously conveyed its strong objections to Council regarding the proposed golf course development at Long Bow Point, recognising Lake Wollumboola's international significance for birds and its high sensitivity to pollution of surface and ground water from its catchment.
- 2.3 The NSW Office of Environment and Heritage 2013 Report advised that the Lake's ecosystem would suffer "catastrophic" consequences and would "never recover" from impacts of development, particularly from a golf course at Long Bow Point.
- 2.4 Previous Councils have sought to have Long Bow Point zoned to enable a golf course to be approved despite this evidence and unanimous long term expert advice. This risky strategy not only threatens this sensitive and unique environment but also the social and economic well-being of Culburra Beach and the wider Shoalhaven given the nature and Aboriginal cultural tourism potential associated with the Lake and its birdlife.
- 2.5 Such benefits far outweigh the claimed benefits of a golf course. In any case the Determination for the Halloran Planning Proposal currently under consideration for the Halloran Trust lands at Culburra Beach provides for investigation of alternative sites for a golf course outside the Lake catchment.
- 2.6 The NSW Department of Planning and Environment has advised Council that as an outcome of the Planning Proposal, Long Bow Point is to be zoned for environment protection. Shoalhaven City Council should accept and support this policy as beneficial to the Shoalhaven and the entire State and not stand in the way of the Minister's actions regarding Lake Wollumboola and the golf course DA.
- 2.7 Birdlife Shoalhaven will be advising Minister Stokes and the Hon Shelley Hancock, Member for South Coast and Speaker of the NSW Legislative Assembly of our support for the Government's position.
